GUARANTEE OF DEALER'S OBLIGATIONS

IN CONSIDERATION of Unistar International Pty. Ltd. A.B.N. 66 078 489 148 (hereinafter called "Unistar") having agreed to grant credit facilities to the Applicant/Dealer, _____ (A.B.N. _____), of _____, at the request of the persons whose names and addresses are set forth in the Schedule hereto (" the Guarantors") the said Guarantors HEREBY GUARANTEE to Unistar that due and punctual payment of all moneys which are now due or owing or which may hereafter become due or owing by the Dealer to Unistar (" the money") on the following terms:

1. if the Dealer fails to pay to Unistar as and when due any of the money the Guarantors will immediately pay the said moneys to Unistar.
2. The obligations of the Guarantors under this Guarantee are joint and several.
3. This Guarantee is a continuing Guarantee and Unistar's rights against the Guarantors shall not be affected by any of the following:
 - (a) The Dealer liability under any contract agreement or arrangement between Unistar and the Dealer or any such contract agreement or arrangement being or becoming invalid illegal or unenforceable through any act or omission or by virtue of any legislation;
 - (b) Any indulgence granted to or extension of time given by Unistar to the Dealer or the Guarantors;
 - (c) The death or bankruptcy of the Guarantors or either of them;
 - (d) The moneys due to Unistar by the Dealer ceasing to be recoverable by virtue of the winding up of the Dealer or for any other reasons;
 - (e) Any variation in the terms of any contract agreement or arrangement between Unistar and the Dealer;
 - (f) This Guarantee not being executed by any other person who has agreed undertaken or offered to do so or whose name appears in the Schedule hereto.
4. The Guarantors will not compete with Unistar for any dividend or distribution in any winding up scheme of arrangement or official management of the Dealer.
5. If any payment made to Unistar by or on behalf of the Dealer or Guarantors is subsequently avoided by any statutory provision of otherwise howsoever, such payment is deemed not to have discharged the Guarantors' liability, and in such event Unistar and the Guarantors are to be restored to the position in which they would have been had such payment not been made.
